Dear Shareholder

The Board of Directors of the Company hereby informs the shareholders of the Sub-Funds (the "Shareholders") that the index provider MSCI Inc, of the relevant Reference Indices for the Sub-Funds has announced that as a result of their annual review of the Global Industry Classification Standard (GICS) structure, changes have been made to the GICS classifications within the following sectors: Telecommunication Services, Consumer Discretionary and Information Technology (the "GICS Re-Classification"). A summary of these changes are set out in more detail below and will have effect for the purposes of the Sub-Funds from 3 December 2018. Xtrackers MSCI World Telecom Services UCITS ETF

As a result of the GICS Re-Classification, the Telecommunication Services Sector is being renamed to Communication Services Sector and will be expanded to include additional companies contained in the internet service provider, media and entertainment industries.

Due to these changes, the Reference Index of the Xtrackers MSCI World Telecom Services UCITS ETF Sub-Fund will be changed from "MSCI World Telecommunication Services Total Return Net Index" to "MSCI World Communication Services Total Return Net Index". At the same time the name of the sub-fund will change from "MSCI World Telecom Services UCITS ETF" to "MSCI World Communication Services UCITS ETF." In addition, this will have an effect on the composition of the Reference Index.

Xtrackers MSCI World Consumer Discretionary UCITS ETF

As a result of the GICS Re-Classification, the Consumer Discretionary Sector will include companies providing online marketplaces for consumer products and services, whilst at the same time some of the companies currently included in this sector will no longer be in this sector. This will have an effect on the composition of the Reference Index namely the MSCI World Consumer Discretionary Total Return Net Index.

Xtrackers MSCI World Information Technology UCITS ETF

As a result of the GICS Re-Classification, the Internet & Services Industry and Sub-Industry will be discontinued and a new Sub-Industry will be created called Internet Services & Infrastructure, which will include companies providing services and infrastructure for the internet industry. This will have an effect on the composition of the Reference Index namely the MSCI World Information Technology Total Return Net Index.

For the avoidance of doubt, the index methodologies of the Reference Indices of the Sub-Funds, their investment objectives, investment policies, risk profiles and fees will remain unchanged.
