The board of directors of the Company hereby informs the shareholders of the Sub-Funds (the "**Shareholders**") that Citigroup Index LLC, acting as the index sponsor of the Sub-Funds (the "**Current Index Sponsor**"), has been acquired by London Stock Exchange Group plc (LSEG) and has changed its name to FTSE Fixed Income LLC.

Following the corporate restructure of the Current Index Sponsor, the Reference Indices of the Sub-Funds will be provided by FTSE Fixed Income LLC (the "**New Index Sponsor**"). The New Index Sponsor started the process of discontinuing the use of the trademarks owned by Citigroup Index LLC in all their marketing materials and platforms. The transition period shall conclude by 31 July 2018, when the use of "CITI" names and marketing will cease.

As a result, the names of the Reference Indices of the Sub-Funds will be changed from "Citi [Name of Index]" to "FTSE [Name of Index]" with effect as from 3 May 2018. The Annex to this notice shows the resulting changes to the indices' names.

For the avoidance of doubt, the index methodologies of the Reference Indices of the Sub-Funds, the current names of the Sub-Funds, their investment objectives, investment policies, risk profiles and fees will remain unchanged.

Capitalised terms not defined herein shall have the meaning given to them in the most recent version of the prospectus of the Company (the "**Prospectus**") and the Product Annexes of each of the Sub-Fund.

The revised version of the Prospectus and key investor information document of the Sub-Funds reflecting the changes described above, will be available on the Company's website ([www.Xtrackers.com](http://www.Xtrackers.com)) on or around 4 May 2018 and a copy thereof may be obtained on request, free of charge, at the registered office of the Company or the offices of the local representatives of the Company.
