## Important notice to shareholders of the Company

Dear Shareholder

This letter is to inform you on behalf of the board of directors of the Company (the “**Board of Directors**”) about certain changes to the sub-funds of the Company (the “**Funds**”), as outlined below.

### Changes for Direct Investment Funds Only

Currently, the Funds are permitted to invest in ancillary liquid assets, which include secured and/or unsecured deposits. It is proposed that with effect from on or about 12 November 2018, the Funds' ability to invest in ancillary liquid assets be extended to include units or shares of other UCITS or other collective investment schemes which pursue a money market or cash strategy or which relate to the Reference Index or constituents of the Reference Index.

This change is intended to allow for a more efficient management of the Funds' investment portfolios.

In addition, with effect from on or about 12 November 2018 it is intended to amend the practical operation of the delegation by DWS Investment GmbH as Investment Manager of certain of its sub-portfolio management functions to Deutsche Asset Management (UK) Limited, the Sub-Portfolio Manager, in respect of Direct Investment Funds, in order that such delegation may occur from time to time, in accordance with an agreed process.

### Changes for All Funds of the Company

Furthermore, unless other communication media are specified in the Prospectus or required in accordance with applicable laws and regulations, the Shareholders will be notified of any developments concerning their investment in the Company through the website [www.xtrackers.com](http://www.xtrackers.com) or any successors thereto. The Shareholders are consequently invited to consult this website on a regular basis.
