Effective 1st July 2014, UBS have transferred responsibility for governance, calculation, distribution and licensing of UBS's commodity indices to Bloomberg LP and the indices have been renamed from the "Dow Jones-UBS Commodity Index Family" to the "Bloomberg Commodity Index Family". Thus, the naming of the Deutsche Bank roll-optimised indices based on the UBS indices will be amended to reflect this change.

For the avoidance of doubt, shareholders should note that the Investment Objective and Policy of the Sub-Fund, the Reference Index and the Underlying Assets will remain unchanged.

The above mentioned changes will become effective on 1 August 2014.
