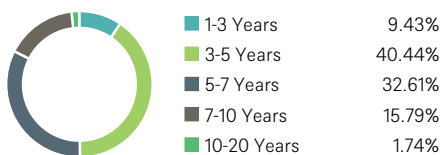

Objective and strategy

Xtrackers High Beta High Yield Bond ETF (the "Fund") seeks investment results that correspond generally to the performance, before fees and expenses, of the Solactive USD High Yield Corporates Total Market High Beta Index (the "Underlying Index") - a rules-based, market value weighted index engineered to mirror the performance of the higher yielding segment of the High Yield rated corporate bond market issued in USD. This index targets the lower quality issuers within the high-yield universe with higher beta relative to the market. The Bloomberg U.S. Universal Index measures the performance of USD taxable bonds which are rated investment grade or high-yield.

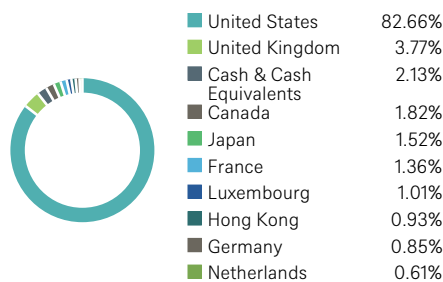

³ Modified Duration to Worst is the measure of sensitivity of the price of a bond to a change in interest rates, assuming worst case scenario. Modified duration is the approximate percentage change in a bond's price for a 100 basis points change in yield, assuming that the bond's expected cash flow does not change when the yield changes.

⁴ Average coupon is the interest rate, expressed as an annual percentage of face value, which a bond issuer promises to pay until maturity.

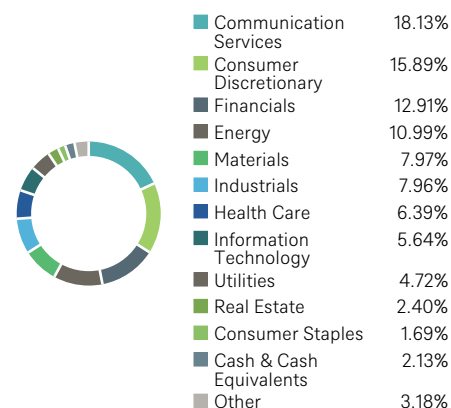
Top 10 country weightings (12/31/25)



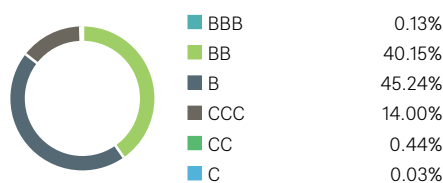
