- The objective of the investment policy is to achieve mid to long-term capital appreciation by investing primarily in equities from developed and emerging markets.
- The invested assets are selected with the primary aim to construct a strategy, which focuses on companies with higher sales and/or earnings growth and/or margins, compared to the broad market.
- Typically the selected companies are characterised by an increasing market share and a growing customer base combined with higher perceived customer satisfaction.
- This usually results in a portfolio of companies offering innovative new products that give the companies a strong bargaining position combined with a degree of pricing power.
