Change of the Registered Office

The current registered office of State Street Bank International GmbH, Luxembourg Branch, acting as the Depositary, Administrative Agent, Paying Agent, Domiciliary Agent and Listing Agent, and Registrar and Transfer Agent of the Company, is 49, avenue J.F. Kennedy, L-1855 Luxembourg, Grand Duchy of Luxembourg.

With effect from 1 July 2026 (the “**Effective Date**”), State Street Bank International GmbH, Luxembourg Branch will change its registered office to 17, Boulevard de Kockelscheuer, L-1821 Luxembourg (the “**SSB Registered Office Change**”).

As a consequence of the SSB Registered Office Change, the registered office of the Company will also be changed to 17, Boulevard de Kockelscheuer, L-1821 Luxembourg from the Effective Date.
