What is this product?

Type

The product is a UCITS - Part 1 sub-fund of a SICAV under Luxembourg law. The fund is a UCITS ETF.

Term

This product is an open-ended fund without predefined maturity. You may request the redemption of shares generally on each valuation date. The company may, however, suspend the redemption if extraordinary circumstances appear to make this necessary, taking into account the interests of the investors. Further, the company may restrict the redemption. The product may be redeemed early in certain circumstances as set out in the sales prospectus. The 1C share class of PostFinance Global Portfolio Xtrackers UCITS ETF was launched in 2026.

Objectives

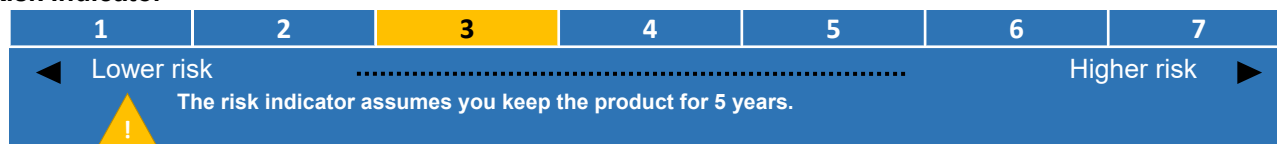
The fund is actively managed. The fund is not managed in reference to a benchmark. **INVESTMENT OBJECTIVE:** The objective of the investment policy is to achieve a positive mid- to long-term investment performance through exposure to a diversified portfolio comprised primarily of exchange-traded funds (ETFs) linked to equities, fixed income, and/or alternatives. The fund will invest primarily in ETFs which may include, but are not limited to, those issued by the Xtrackers, Xtrackers (IE) plc, and Xtrackers II. The fund may also indirectly invest in alternatives through UCITS and/or other UCIs investing in financial derivative instruments on commodity indices, ETFs and/or ETCs, and/or structured products. The fund may also invest from time to time in transferable securities, money market instruments, other collective investment schemes, or other eligible assets (Invested Assets). **ALLOCATIONS:** The sub-portfolio manager for the fund is DWS Investments UK Limited (Sub-Portfolio Manager). The Sub-Portfolio Manager has appointed PostFinance Ltd. (Allocation Advisor) to provide investment advice with regard to the composition of the fund's Invested Assets (Proposed Allocation). The composition of the Invested Assets will be selected with the primary aim of creating a total return strategy, which seeks to benefit from capital appreciation generated by the exposures of the Proposed Allocation and/or Invested Assets, while minimising certain market risks. In order to seek to achieve the Investment Objective, the Allocation Advisor and/or Sub-Portfolio Manager will consider and analyse data which is considered relevant in the selection of the Proposed Allocation and/or Invested Assets, including, but not limited to, macroeconomic and currency-related information. The Proposed Allocation will be provided by the Allocation Advisor at least on a scheduled semi-annual basis. Such Proposed Allocation may be implemented, whether in whole or in part, at the absolute discretion of the Sub-Portfolio Manager and accordingly the Invested Assets of the fund may differ from the Proposed Allocation. **INVESTMENT POLICY:** The fund may employ techniques and instruments in order to manage risk, reduce costs and improve results. These techniques and instruments may include the use of financial contracts (derivatives). **FURTHER INFORMATION:** Certain information (including the latest share prices of the fund, indicative net asset values and full disclosure on the composition of the fund's portfolio) is available on your local DWS website or at www.Xtrackers.com. The return of the product is reflected by the daily calculated net asset value per unit and the distribution amount if applicable. The currency of the fund is CHF. Returns and gains are not distributed but are reinvested in the fund. This fund is a sub-fund of Xtrackers for which the sales prospectus and the periodic reports are prepared as a whole. The assets and liabilities of each sub-fund are segregated by law. As a result, assets of one sub-fund are not available in the event of claims against or insolvency of another. More share classes may be available for this fund - please refer to the relevant section of the sales prospectus for further details. You are not permitted to exchange your shares in this fund for other funds of Xtrackers. The depositary is State Street Bank International GmbH, Luxembourg Branch. The fund is designed for: (i) retail clients with (ii) basic knowledge and experience and (iii) are prepared to accept the level of risk indicated below (including losses up to the total invested amount). What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity to pay you.

What happens if DWS Investment S.A. is unable to pay out?

The assets of the fund are kept separately from those of the management company, DWS Investment S.A.. An insolvency or default of the management company should not result in the fund suffering any financial loss in relation to its assets. On the insolvency or default of the depositary State Street Bank International GmbH, Luxembourg Branch securities held by the depositary on behalf of the fund should be protected but the fund may suffer loss in relation to cash and certain other assets which are not protected. Cash deposits of the fund deposited with other credit institutions may cause investors to suffer a financial loss if such deposits are not covered by any existing deposit guarantee schemes. Investment in the fund is not covered by any investor compensation or guarantee scheme.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed: In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario. 10.000 CHF is invested.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years. The product has no minimum holding period.

This product has no required minimum holding period. The recommended holding period has been selected due to its investment strategy and because it is designed for a medium term investment horizon. It is expected that it will be possible to achieve the investment objective of the fund within this time frame. You may request the redemption of shares generally on each valuation date. No fees or penalties will be charged by the company for any such transaction.

There is no change on the risk return profile when you redeem your shares early.
