Xtrackers MSCI Kokusai Equity ETF seeks investment results that correspond generally to the performance, before fees and expenses, of the MSCI Kokusai Index. The MSCI Kokusai Index is also known as the MSCI World ex Japan Index. The MSCI Kokusai Index, also known as the MSCI World ex Japan Index, is a market capitalization weighted index designed to provide exposure to the large- and mid-cap equity securities in 22 of the 23 developed stock market across the world, excluding Japan. The MSCI World Index tracks the performance of stocks in select developed markets around the world, including the United States.

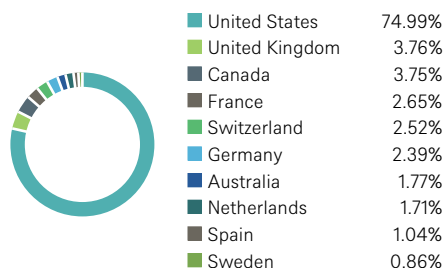

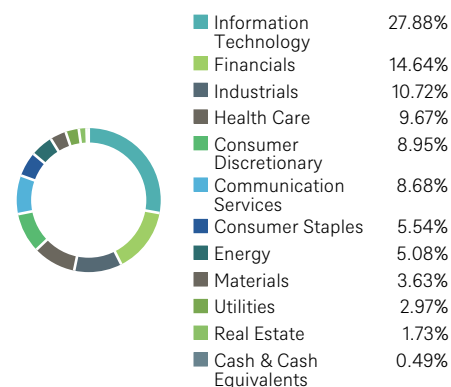

While the 10-year overall rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods.
