- The investment objective of the Fund is to achieve an excess return over a benchmark reflecting the performance of investment-grade, euro-denominated floating-rate notes with a maturity of up to three years through investment in fixed income securities
- In order to achieve the investment objective, the Fund will adopt a Direct Investment Policy, which is actively managed, against the iBoxx EUR FRN Investment Grade 0-3 Capped Index as a performance benchmark
- In order to seek to achieve its investment objective, the Fund: (i) will invest primarily in issuers contained in the Performance Benchmark ("Benchmark Issuers"); and ii) may also invest from time to time in other fixed income securities (such as non-EUR denominated floating rate notes hedged against the euro and other corporate or government bonds), money market instruments, collective investment schemes, or other eligible assets for purposes including, but not limited to, investing temporary cash balances and efficient portfolio management in accordance with the Investment Restrictions (together with the Benchmark Securities, referred to as the "Invested Assets").
- The Investment Manager for the Fund is DWS Investment GmbH. The Sub-Portfolio Manager is DWS Investments UK Limited. Both the Investment Manager and Sub-Portfolio Manager will be responsible for the day-to-day investment management of the Fund, including the allocation of the Invested Assets, cash re-investments, and management of creations and redemptions.
