The iBoxx EUR Sovereigns ESG Tilted Index aims to reflect the performance of the following market:

- Fixed-rate, Euro currency, investment-grade sovereign bonds only.
- Exposure across the whole yield curve (minimum time to maturity of 1 year).
- Universe of eligible bonds must meet certain ESG criteria.
- Country Weights are tilted so the index provides higher exposures to countries that have a higher ESG score, and lower exposures to countries that have a lower ESG score.
- All issuers with a Sustainalytics Country-Risk Category of "Severe" will be excluded from the index.
- The Index only includes bonds from issuers with a Freedom House Global Freedom Status of 'Free' or 'Partly Free'.
