Objective and strategy

Xtrackers Semiconductor Select Equity ETF (the “fund”) seeks investment results that correspond generally to the performance, before fees and expenses, of the Solactive Semiconductor ESG Screened Index (the “Underlying Index”). The index is a representation of securities that have business operations in the semiconductor industry and that fulfill certain sustainability criteria. Companies in the semiconductor field face intense competition which may have an adverse effect on profit margins. Cybersecurity companies also face heightened risk due to their dependence on the availability of materials that meet exacting standards, reliance on a limited number of suppliers and potential loss or impairment of patent and intellectual property rights. The MSCI All Country World Index (ACWI) is a global equity index that measures the equity performance in both the developed and emerging markets by tracking the performance of 47 countries comprising 23 developed and 24 emerging markets.

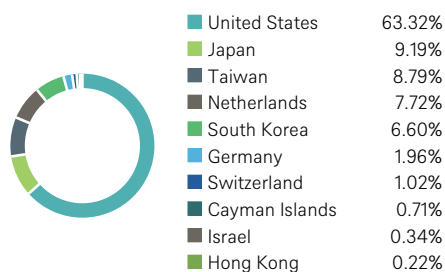
