Objective and strategy

On 2/10/25 the fund changed its name from Xtrackers S&P 500 Growth ESG ETF to Xtrackers S&P 500 Growth Scored & Screened ETF. The underlying index of the fund, the S&P 500 Growth ESG Index, also changed its name to the S&P 500 Growth Scored & Screened Index. There were no changes to the index methodology of the Underlying Index and no changes in the investment policies of the fund.

Xtrackers S&P 500 Growth Scored & Screened ETF (the "fund"), seeks investment results that correspond generally to the performance, before fees and expenses, of the S&P 500 Growth ESG Index (the "Underlying Index"). The Underlying Index is derived from the S&P 500 Growth Scored & Screened Index, which, in turn, is derived from the S&P 500 Index. The Index Provider constructs the S&P 500 Growth Index by applying a proprietary growth/value analysis methodology to the constituent companies of the S&P 500 Index. It then constructs the Underlying Index by applying a proprietary ESG methodology to the constituent companies of the S&P 500 Growth Index. S&P 500 Index tracks the performance of 500 leading U.S. stocks and is widely considered representative of the U.S. equity market.

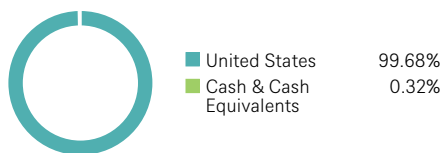

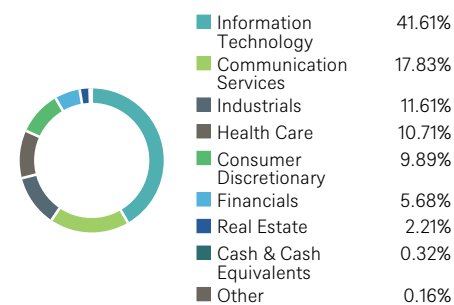

The weights are 100% three-year rating for 36-59 months of total returns, 60% five-year rating/40% three-year rating for 60-119 months of total returns, and 50% 10-year rating/30% five-year rating/20% three-year rating for 120 or more months of total returns. While the 10-year overall rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods.
