Xtrackers is the brand name for the exchange-traded funds (ETF) managed by DWS. ETFs are regulated, open-ended investment funds that trade on stock exchanges just like any other listed, tradable security. They combine in a single, easy to use product the key intraday trading and liquidity elements of stocks with the diversification offered by an index fund. Since launch in 2007, Xtrackers has grown rapidly. It now has around CHF 129.01 bn in assets under management (as of March, 2024) across more than 150 products, making Xtrackers one of the largest ETF provider in Europe and amongst the top providers globally.




