Objectives and investment policy

The fund is passively managed. INVESTMENT OBJECTIVE: The aim is for your investment to reflect the performance of the MSCI China A Inclusion Index (index). DESCRIPTION OF INDEX: The index is designed to reflect the performance of certain shares of large and medium capitalisation Chinese companies listed on onshore exchanges such as on the Shanghai and Shenzhen exchanges (A-Shares) and accessible through the Stock Connect framework. Only Chinese company A shares which are included in the MSCI Emerging Markets Index are eligible for inclusion. INDEX REBALANCING, CALCULATION AND ADMINISTRATION: The composition of the index is reviewed at least quarterly. The index is calculated on a total return net basis which means that all dividends and distributions of the companies are reinvested in the shares after tax. INVESTMENT POLICY: To achieve the aim, the fund will attempt to replicate the index, before fees and expenses, by buying all or a substantial number of the securities in the index. The fund may employ techniques and instruments in order to manage risk,

reduce costs and improve results. These techniques and instruments may include the use of financial contracts (derivatives). The fund may also engage in secured lending of its investments to certain eligible third parties to generate additional income to offset costs of the fund. 

To the extent the fund undertakes securities lending to generate revenue, the fund will ultimately be allocated 82% of the associated revenue, the securities lending agent, which will be a Deutsche Bank entity, will be allocated 9% and the remaining 9% will be allocated to the DWS entity which monitors such activities, as set out in the sales prospectus and/or supplement, for its own coordination and oversight tasks. As securities lending revenue sharing does not increase the costs of running the fund, this has been excluded from the composition of
