Objectives and investment policy

The fund is passively managed. INVESTMENT OBJECTIVE: The aim is for your investment to reflect the performance of the Solactive €STR +8.5 Daily Total Return Index (index). DESCRIPTION OF INDEX: The index reflects the performance of a deposit earning interest at the Euro short term rate (€STR) plus 8.5 basis points, with the interest being re-invested in the deposit on a daily basis. INDEX REBALANCING, CALCULATION AND ADMINISTRATION: The index is administered by Solactive AG and is calculated in EUR on any day that is (or, but for the occurrence of a market disruption event, would have been) a day (other than a Saturday or Sunday) that is not a holiday based on the Target 2 calendar. There is no rebalancing of the index. INVESTMENT POLICY: To achieve the aim, the fund will invest in transferable securities and enter into financial contracts (derivatives) with one or

more swap counterparties relating to the transferable securities and the index, in order to obtain the return on the index. FURTHER INFORMATION: Certain information (including the latest share prices of the fund, indicative net asset values, full disclosure on the composition of the fund's portfolio and information on the index constituents) are available on your local DWS website or at www.Xtrackers.com. The anticipated level of tracking error in normal market conditions is 1 per cent. The currency of the fund is EUR. The fund may distribute up to four times per annum. You may request the redemption of shares generally on a daily basis.


