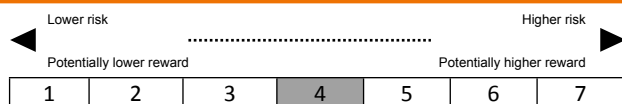

### Objectives and investment policy

The fund is passively managed. **INVESTMENT OBJECTIVE:** The aim is for your investment to reflect the performance of the Markit iBoxx EUR Liquid High Yield 1-3 Index (index). **DESCRIPTION OF INDEX:** The index reflects the performance of the largest and the most liquid sub-investment grade corporate bonds denominated in Euro and issued by companies based both inside and outside of the Eurozone. The composition of the index is reviewed and rebalanced on a monthly basis. For new bonds to be included in the index, they must, on the relevant rebalancing date, have a minimum remaining time to maturity of at least one year and up to three years. The bonds can have a fixed or floating rate of interest and must be rated less than Baa3/BBB- by major rating agencies. **INDEX REBALANCING, CALCULATION AND ADMINISTRATION:** The index is administered by IHS Markit Benchmark Administration Limited. **INVESTMENT POLICY:** To achieve the aim, the fund will

invest in transferable securities and enter into financial contracts (derivatives) with one or more swap counterparties relating to the transferable securities and the index, in order to obtain the return on the index. **FURTHER INFORMATION:** Certain information (including the latest share prices of the fund, indicative net asset values, full disclosure on the composition of the fund's portfolio and information on the index constituents) are available on your local DWS website or at [www.Xtrackers.com](http://www.Xtrackers.com). Transaction costs and taxes, unexpected fund costs and market conditions such as volatility or liquidity issues may affect the ability of the fund to track the index. The anticipated level of tracking error in normal market conditions is 1 per cent. The currency of the fund is EUR. The fund distributes up to four times per annum. You may request the redemption of shares generally on a daily basis.

### Risk and reward profile

The charges you pay are used to pay the costs of running the fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

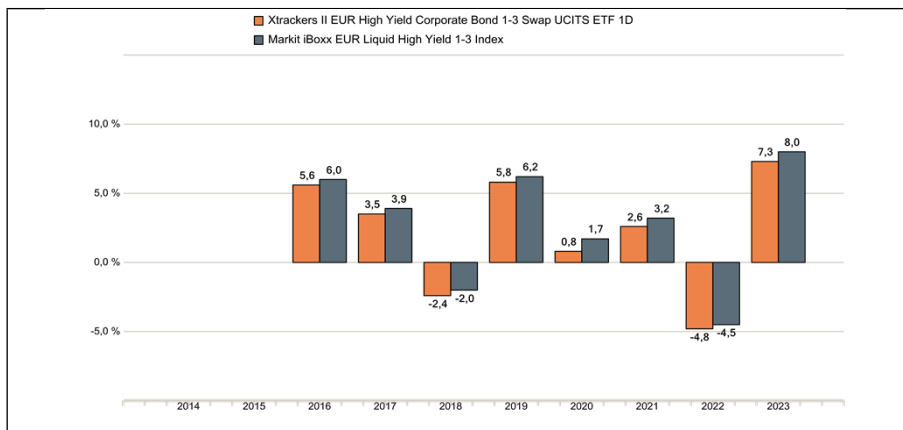
