Objectives and investment policy

The fund is passively managed. INVESTMENT OBJECTIVE: The aim is for your investment to reflect the performance of the Solactive FEDL Daily Total Return Index (index). DESCRIPTION OF INDEX: The index reflects the performance of a notional deposit earning the federal funds effective rate with interest being reinvested in the deposit daily. INDEX REBALANCING, CALCULATION AND ADMINISTRATION: The index is administered by Solactive AG and is calculated in USD on each day (other than a Saturday or a Sunday) on which commercial banks, foreign exchange markets and clearing agents are open and settle payments in New York. There is no rebalancing of the index. INVESTMENT POLICY: To achieve the aim, the fund will invest in transferable securities and enter into financial

(derivatives) with one or more swap counterparties relating to the transferable securities and the index, in order to obtain the return on the index. FURTHER INFORMATION: Certain information (including the latest share prices of the fund, indicative net asset values, full disclosure on the composition of the fund's portfolio and information on the index constituents) are available on your local DWS website or at www.Xtrackers.com. 
