DESCRIPTION OF INDEX: The Index applies two sets of rules independently, Lowest Carbon Exposure Selection Rules and ESG Performance Selection Rules. INDEX Highest REBALANCING, CALCULATION AND ADMINISTRATION: The index is calculated on a total return net basis which means that all dividends and distributions by the companies are reinvested in the shares after tax. 
