Objectives and investment policy

The fund is passively managed. INVESTMENT OBJECTIVE: The aim is for your investment to reflect the performance of the MSCI EM Latin America Low Carbon SRI Leaders Index (index). DESCRIPTION OF INDEX: The index is designed to reflect the performance of companies that have lower current and potential carbon exposure than that of the broader equity market in emerging market countries in Latin America and have high ESG performance. DESCRIPTION OF INDEX: The Index applies two sets of rules independently, Lowest Carbon Exposure Selection Rules and ESG Performance Selection Rules. INDEX Highest REBALANCING, CALCULATION AND ADMINISTRATION: The index is calculated on a total return net basis which means that all dividends and distributions by the companies are reinvested in the shares after tax. 
