We hereby inform you that the Programme Counterparty in accordance with the underlined wording has determined that for the Scheduled Valuation Days on 24 December 2019 and 31 December 2019 the Metal Fixing Time will be changed to the times below. This is because on 24 December 2019 and 31 December 2019 there will be no afternoon metal auction and therefore no p.m. fixing value published for the Metal Reference Price Source. However, there will be a morning metal auction fixing available.

For Series where the Metal is Platinum or Palladium: 9.45 a.m. London time.
