### **Objectives and investment policy**

The fund is passively managed. INVESTMENT OBJECTIVE: The aim is for your investment to reflect the performance of the iBoxx EUR Eurozone Sovereigns Green Bonds Capped Index (index). DESCRIPTION OF INDEX: The index aims to reflect the performance of Sovereign Green bonds denominated in EUR which are issued by Eurozone Governments to fund projects with direct environmental benefits and that meet specific credit quality and liquidity requirements. The Green Bonds must also adhere to the criteria set out in the Climate Bonds Initiative's Climate Bonds Taxonomy. ESG CRITERIA: In order to be eligible for inclusion in the index, the issuers of the bonds must also meet certain environmental, social and governance (ESG) screening criteria. Bonds which breach the following ESG standards, amongst others, are excluded: (i) All issuers with a Sustainalytics Country-Risk Category of "Severe" will be excluded from the index; and (ii) All issuers must have a Freedom House Global Freedom Status of "Free" or "Partly Free". INDEX REBALANCING, CALCULATION AND ADMINISTRATION: The index is reviewed and rebalanced monthly, where the aggregate weight for any country will be capped at 35% and any excess will be distributed to all the remaining bonds


