Objectives and investment policy

The fund is passively managed. INVESTMENT OBJECTIVE: The fund aims to reflect the performance of the Solactive ISS ESG Nordic Investable Universe Net Zero Pathway Index (index). DESCRIPTION OF INDEX: The Reference Index is designed to reflect the performance of companies of the Nordic countries which are selected and weighted with the aim of seeking alignment with EU Paris-aligned Benchmark (EU PAB) standards and certain net zero frameworks. The index uses ESG data from Institutional Shareholder Services Inc. (ISS), which provides expertise across a variety of sustainable and responsible investment issues. ESG CRITERIA: The index first removes companies from the Solactive GBS Developed Markets Nordic Investable Universe EUR Index (parent index) which do not meet certain ESG criteria, as disclosed in the prospectus and/or supplement. Stocks passing these exclusions are then scored and weighted based on three pillars (Tilted Weights) (i) Science-based targets relating to reducing carbon emissions (ii) Climate disclosure standards, and (iii) Green revenue relating to SDG 13. Tilted Weights are then further adjusted to ensure alignment with EU PAB requirements, with weights subject to capping and individual and sector weight deviation limits compared to the parent index also applied. Individual securities in the index are capped at 9%. INDEX REBALANCING, CALCULATION AND ADMINISTRATION: The

Index is administered by Solactive AG. The index is calculated on a total return net basis which means that all dividends and distributions by the companies are reinvested in the shares after tax. The index is reviewed and rebalanced on at least a semiannual basis. The index is calculated in EUR on a daily basis. INVESTMENT POLICY: To achieve the aim, the fund will attempt to replicate the index, before fees and expenses, by buying all or a substantial number of the securities in the index. The fund may employ techniques and instruments in order to manage risk, reduce costs and improve results. These techniques and instruments may include the use of financial contracts (derivatives).
