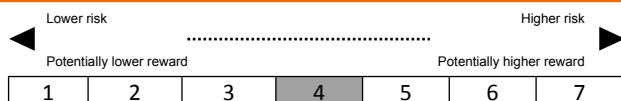

Objectives and investment policy

The fund is passively managed. **INVESTMENT OBJECTIVE:** The aim is for your investment to reflect the performance of the FTSE ESG Select World Government Bond Index – DM (index), while seeking to minimise foreign currency fluctuations at share class level. **DESCRIPTION OF INDEX:** The index is designed to reflect the performance of fixed-rate, local currency, investment-grade sovereign debt issued in developed markets, excluding countries which do not fulfil specific ESG (environmental, social, and governance) criteria. **ESG CRITERIA:** Issuers are selected from the FTSE World Government Bond Index – DM (Parent Index) and country ESG scores are calculated by evaluating each country's ESG risk across three ESG pillars as determined by LSEG Sustainable Sovereign Risk Methodology (2SRM). To be included in the index, a country must be classified as 'Free' by Freedom House, not be subject to social violations based on data from Sustainalytics and not be included on the EU list of non-cooperative jurisdictions for tax purposes. Countries are ranked by their ESG score and must exceed a certain threshold for inclusion. The weight for each security is "tilted" as set out in the Product Annex of the fund. A green bond tilt is then applied to ensure that green bonds meet a certain minimum threshold of the index, while maintaining the country weights previously calculated. **INDEX REBALANCING, CALCULATION AND ADMINISTRATION:** The index is calculated on a total return basis, which means that amounts equivalent to

interest payments are reinvested in the index. The index is administered by FTSE Fixed Income LLC and rebalanced monthly. **INVESTMENT POLICY:** To achieve the aim, the fund will i) attempt to replicate the index, before fees and expenses, by buying a portfolio of securities that may comprise the constituents of the index or other unrelated investments as determined by DWS entities and ii) enter into financial contracts (derivatives) which attempt to reduce the effect of exchange rate fluctuations between the currency of the fund's assets and the currency of your shares. The fund may employ techniques and instruments in order to manage risk, reduce costs and improve results. These techniques and instruments may include the use of derivatives. **FURTHER INFORMATION:** Certain information (including the latest share prices of the fund, indicative net asset values, full disclosure on the composition of the fund's portfolio and information on the index constituents) are available on your local DWS website or at www.Xtrackers.com. Transaction costs and taxes, unexpected fund costs and market conditions such as volatility or liquidity issues may affect the ability of the fund to track the index. The anticipated level of tracking error in normal market conditions is 1 per cent. The currency of the fund is EUR. The fund distributes up to four times per annum. You may request the redemption of shares generally on a daily basis.

Risk and reward profile



The calculation of the risk and reward profile is based on simulated data that cannot be used as a reliable indicator for the future risk profile. This risk indicator is subject to changes; the classification of the fund may change over time and cannot be guaranteed. Even a fund that is classified in the lowest category (category 1) does not represent a completely risk-free investment. The fund is classified in category 4 because its share price fluctuates and the likelihood of both losses and gains may therefore be relatively high. The following risks could be of particular significance for the fund: The fund will attempt to replicate the performance of the index less costs, but your investment is not expected to match the performance of the index precisely. **EXCEPTIONAL CIRCUMSTANCES RISK:** Exceptional circumstances may arise, such as, but not limited to, disruptive market conditions, additional costs/taxes or extremely volatile markets, which may cause the fund's performance to be substantially different from the performance of the index. **CONFLICTS OF INTEREST RISK:** DWS entities and related companies may act in several roles in relation to the fund such as distributor and management company which may involve conflicts of interest. **NO GUARANTEE RISK:** The fund is not guaranteed and your investment is at risk. The value of your investment may go down as well as up. **BONDS RISK:** The index provides a notional exposure to the value and/or return of certain bonds which may fall. Markets in these asset classes may at times

become volatile or illiquid. This means that ordinary trading activity may occasionally be disrupted or impossible. **CURRENCY RISK:** Fluctuations in interest rates of the currency of the shares, the index or the other assets of the fund may affect the value of your investment. **DERIVATIVES RISK:** The fund may use derivatives to i) try to manage its investments more efficiently and ii) try to reduce movements in currency exchange rates between the currency of the fund's assets and the currency of the fund's shares. This may not always be successful and may result in greater fluctuations in the value of the fund. This may negatively affect the value of the fund and your investment. **CREDIT RISK & INTEREST RATE RISK:** The fund may invest in bonds which are exposed to credit risk and interest rate risk. **SUSTAINABILITY RISK:** The environmental, social and governance screening criteria are embedded with the index selection process, which seeks to exclude bonds issued by companies involved in certain activities. The investment manager and sub-portfolio manager are not responsible for monitoring the screening process or confirming that all bonds which pass the screening process are issued by companies with adequate environmental, social or governance standards. The issuer is solely relying on the activities conducted by and information provided by the administrator of the reference index for the ESG screening. ESG information from third-party data providers may be incomplete, inaccurate or unavailable. As a result, there is a risk that the index administrator may incorrectly assess a security or issuer, resulting in the incorrect inclusion or exclusion of a security in the index and therefore the portfolio of the fund.

Charges

The charges you pay are used to pay the costs of running the fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

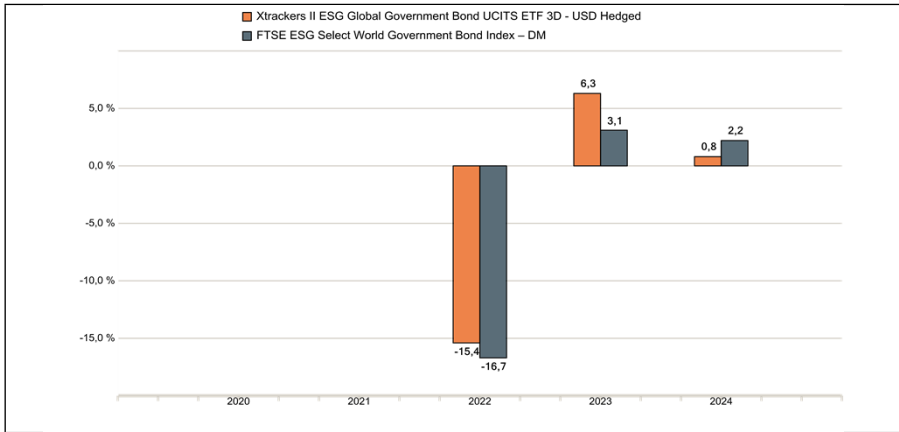
