Impact of New Reporting Fund Regime in the UK on db x-trackers Exchange Traded Funds (ETFs)



Introduction

On 1 December 2009, Her Majesty's Revenue & Customs (HMRC) introduced the Reporting Fund regime applicable to offshore funds with UK investors. This replaced the UK Distributor Status regime which had been in place since 1984.

This document provides an overview of the impact of these changes on the db x-trackers ETF range in the UK.

Distributor Status (DS)

To obtain DS, offshore funds have to demonstrate that they distribute to investors at least 85% of the higher of a fund's net income and UK equivalent profits for each accounting period. If a fund is certified as a distributing fund throughout the entire period of ownership by an investor then any gains made on the disposal of the units/shares of the fund are treated as a capital gain for UK individuals or a chargeable gain for UK corporations.

The application for DS certification for each accounting period is made retrospectively, within six months of the end of that accounting period.

Reporting Fund (RF)

The RF regime was introduced to simplify some aspects of the DS regime and create a level playing field with on-shore UK funds. The key differences between the RF and DS regimes are:

- There is no need for a fund to make actual distributions. Instead a fund is required to report to investors and HMRC 100% of the "reportable income" (with a 10% margin of error) for each period of account. Investors will then be taxed on the excess of the reportable income over any income actually distributed (please see below).
- The application for RF is made within three months of the beginning of the first relevant period of account or within three months of the launch of a new fund. Compared to the DS regime where the certification application is made retrospectively, the new RF rules provide some certainty for investors at the time of investment.

Taxation of UK Investors

UK individual investors holding units/shares in a fund complying with the RF regime will be taxed as follows:

On distributions and deemed distributions: UK individual investors will pay tax on any distributed income (as dividend income for distributions from an equity fund and as savings income for distributions from a bond fund). Any excess reportable income over the income actually distributed (if any) will be deemed distributed and taxable as above.

The dividend ordinary rate, dividend upper rate and dividend additional rate for individuals for income tax purposes for 2010/11 are respectively 10%, 32.5% and 42.5%. Dividend tax credits are available which result in effective tax rates of 0%, 25% and 36.11% respectively. The basic rate, higher rate and additional rate for individuals for income tax purposes for 2010/11 for savings income are 20%, 40% and 50% respectively, with a 10% (rather than the basic rate) starting rate for savings income up to the starting rate limit for savings of £2,440 for 2010/11 also applying in certain

On disposal: Capital gains tax is payable on any gains made on the disposal of the units/shares of the fund, currently levied at a flat rate of 28% for those paying income tax at the higher or additional rates, or 18% for those below those thresholds. There is an annual exemption for the first £10,100 of gains in the year 2010/11.

Transition Period between DS and RF

Although the new RF regime came into effect on 1 December 2009, there will be a transition period whereby existing offshore funds with distributor status with an accounting period straddling 1 December 2009 (the overlap period) can opt to apply for DS for the overlap period and also for the immediately following period. Therefore, an offshore fund platform with accounting periods ending 31 December 2009 and 2010, could opt to remain under the DS regime for both years but would then need to switch to the RF regime for the accounting period ending 31 December 2011.

Impact on db x-trackers ETFs

- All db x-trackers ETFs are managed such that they will be compliant with either the DS or RF reporting requirements.
- db x-trackers ETFs are offered from two umbrella fund investment companies domiciled in Luxembourg - db x-trackers and db x-trackers II
- From the **db x-trackers** investment company, the ETFs based on equity, commodity, currency, hedge fund and money market indices are offered. From the db x-trackers II investment company, ETFs based on fixed income indices are offered.
- The accounting period for both investment companies is 1 January to 31 December.
- In the case of ETFs offered from the **db x-trackers** investment company:
 - The first accounting period for which DS was applied for was for the period ended 31 December 2007 and the subsequent one was for the period ended 31 December 2008 and 31 December 2009.
 - For the accounting period, 1 January 2010 to 31 December 2010, DS will be applied for by 30 June 2011. For the ETFs launched during this period, they will be managed such that DS certification can be achieved when applied for.
 - For the accounting period, 1 January 2011 to 31 December 2011, the ETFs will apply for Reporting Fund Status.
- In the case of ETFs offered from the db x-trackers II investment
 - DS has not been applied for any accounting period as these funds have not been offered extensively to UK investors.
 - For the accounting period, 1 January to 31 December 2010, the ETFs have applied for Reporting Fund Status.
 - For the accounting period, 1 January 2011 to 31 December 2011, the ETFs will apply for Reporting Fund Status.

The tables on the next pages show the accounting period for which DS or RF has been or will be applied for each db x-trackers ETF available to UK investors.

Investors should refer to the relevant fund factsheet or fund data page on the db x-trackers website (www.dbxtrackers.co.uk) to check the tax status of each db x-trackers or db x-trackers II ETF.
