What is this product?

The product is a UCITS - Part 1 sub-fund of a SICAV under Luxembourg law. The fund is a UCITS ETF.

Term

This product has a maturity until 30.09.2031. You may request the redemption of shares generally on each valuation date. The company may, however, suspend the redemption if extraordinary circumstances appear to make this necessary, taking into account the interests of the investors. Further, the company may restrict the redemption. The product may be redeemed early in certain circumstances as set out in the sales prospectus. The 1C share class of Xtrackers II Target Maturity Sept 2031 EUR Corporate Bond UCITS ETF was launched in 2024.

Objectives

The fund is passively managed. The fund promotes environmental and social characteristics and is subject to the disclosure requirements of a financial product in accordance with article 8(1) of Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial services sector. More ESG information is available in the sales prospectus and on the DWS website. DESCRIPTION OF INDEX: The aim is for your investment to reflect the performance of the Bloomberg MSCI Euro Corporate September 2031 SRI Index (index). The index aims to reflect the performance of the investment grade, euro-denominated, fixed-rate corporate bond market with maturity dates on or between 1 October 2030 and 30 September 2031, and excluding bonds which do not fulfil specific ESG criteria. The bonds must meet certain sector, amount outstanding, and security type criteria. From 1 October 2030, the Reference Index will also include certain Euro-denominated Treasury bills issued by certain European governments with 1 to 3 months remaining to maturity, and which fulfil certain ESG criteria (bills). ESG CRITERIA: Based on MSCI ESG Research, the index excludes: (i) sovereign issuers rated below BB or, (ii) corporate issuers rated below B, (iii) corporate issuers with a "red" Controversies score, (iv) corporate issuers breaching certain thresholds in controversial activities, and (v) Sovereign issuers classified as "Not Free" or "Partly Free" based on Freedom House data. INDEX REBALANCING, CALCULATION AND ADMINISTRATION: The weight of each corporate issuer is limited to 3%. From the 1 October 2030 cash amounts received from maturing bonds will be re-invested into bills rather than corporate bonds at each rebalance. The index is rebalanced monthly. The index is administered by Bloomberg Index Services Limited. The index is calculated on a total return basis which means that the payments from coupons are reinvested. INVESTMENT POLICY: To achieve the aim, the fund will attempt to replicate the index, before fees and expenses. by buying a portfolio of securities that may comprise the constituents of the index or other unrelated investments as determined by DWS entities. The fund may employ techniques and instruments in order to manage risk, reduce costs and improve results. These techniques and instruments may include the use of derivatives. The anticipated level of tracking error in normal market conditions is 1 per cent. The return of the product is reflected by the daily calculated net asset value per unit and the distribution amount if applicable. The currency of the fund is EUR. Returns and gains are not distributed but are reinvested in the fund. This fund is a sub-fund of Xtrackers II for which the sales prospectus and the periodic reports are prepared as a whole. The assets and liabilities of each sub-fund are segregated by law. As a result, assets of one sub-fund are not available in the event of claims against or insolvency of another. You are not permitted to exchange your shares in this fund for other funds of Xtrackers II. The depositary is State Street Bank International GmbH, Luxembourg Branch. Risk Indicator

What happens if DWS Investment S.A. is unable to pay out?

The assets of the fund are kept separately from those of the management company, DWS Investment S.A.. What are the costs?

Costs over time

How long should I hold it and can I take money out early?

Recommended holding period: 7.08 years. The product has a fixed maturity date as of 30.09.2031.

This product has no required minimum holding period. The recommended holding period has been selected due to its investment strategy and because it is designed for a long term investment horizon. It is expected that it will be possible to achieve the investment objective of the fund within this time frame. You may request the redemption of shares generally on each valuation date. No fees or penalties will be charged by the company for any such transaction.

There is no change on the risk return profile when you redeem your shares early.
