Current Situation

In the context of the announcement of the FINMA and the SNB on 15th of March related to Credit Suisse Group AG, as well as the subsequent announcement of Credit Suisse Group AG on 16th of March, we want to provide transparency to our investors on the exposures towards securities issued by Credit Suisse Group AG or its affiliated entities.

As of March 10th, 2022, the retail mutual funds and ETFs managed by DWS Investment GmbH (Germany) and DWS Investment S.A. (Luxembourg) hold a combined value of €412mln in shares and debt instruments by entities part of DWS Group.

Security Group 1: Shares issued by Credit Suisse Group AG. Total exposure to this group of securities: €16mln

Security Group 2: Debt instruments issued by Credit Suisse Group AG including those with expected similar seniority (HoldCo Senior). Total exposure to this group of securities: €100mln

Security Group 3: Debt instruments issued by Credit Suisse AG including those with expected similar seniority (OpCo Senior). Total exposure to this group of securities: €296mln

There is no exposure observed to AT1 debt instruments.
