The dividend per share which will effectively be paid will be announced by way of a notice on 30 March 2015.

¹ The Record Date is defined under Article IA.2.1.2 (1)(a) of Borsa Italiana Rules as the date in which the right to payment of the dividend under Article 83-terdecies of the Consolidated Financial Act arises and needs to be T+2 from the "Last Trading Date before the Ex-Dividend Date". Please also note that the Record Date shall be a business day in Luxembourg and in Italy.
